Guidelines for applying for a Public Defender

- You will NOT be appointed a public defender on a Thursday, it is a court date and we are extremely busy. Make sure the information on your application is legible and current.
- 2. You must apply in person, **\$5.00** is due the day you turn in your application.
- 3. You must provide income verification, (medical coupon, EBT card, pay stubs).
- 4. You will need to provide a piece of mail with your **current** mailing address.
- 5. The application must be completely filled out and legible.

You must bring the application, and have verification of income and address. You will not be appointed without these things.

If you are appointed a Public Defender, it is **your responsibility** to contact them and keep in good contact with them. You must notify the court **and** your Public defender of any address changes as well as phone contact information.

If any Public Defender recoupment fees are assessed by the Judge, they will be added in when your case is resolved. You will **not** be required to pay them up front. However, if your case goes to warrant you could be required to pay a **\$50.00** warrant recall fee when your case is resolved.

No one will be appointed a Public Defender on court day (Thursday). You will need to ask for a continuance to see if you qualify for a Public Defender. You cannot apply or leave your application on a court day!
